What Does Pacific Global Bank Do With Your Personal Information?

Why? Financial companies choose how they share your personal information. Federal law gives consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share and protect your personal information. Please read the notice carefully to understand what we do.

What? The types of personal information we collect and share depend on the product or service you have with us. This information can include:

- Social Security number and Credit History
- Income and Employment Information
- Assets and Transaction or Loss History

When you are *no longer* our customer, we continue to share your information as described in this notice.

How? All financial companies need to share customers' personal information to run their everyday business. In the section below, we list the reasons financial companies can share their customers' personal information; the reasons Pacific Global Bank chooses to share; and whether you can limit this sharing.

What we do

How does Pacific Global Bank protect my personal information?

To protect your personal information from unauthorized access and use, we use security measures that comply with federal law. These measures include computer safeguards and secured files and buildings.

How does Pacific Global Bank collect my personal information?

We collect your personal information, for example, when you

- Open an account or give us your contact information
- Apply for a loan or use your ATM, debit or credit card
- Provide your government issued photo identification documents

We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.

Why can't I limit all sharing?

Federal law gives you the right to limit only

- sharing for affiliates' everyday business purposes - information about your creditworthiness
- affiliates from using your information to market to you
- sharing for nonaffiliates to market to you

State laws and individual companies may give you additional rights to limit sharing.

Definitions

Affiliates: Companies related by common ownership or control. They can be financial and nonfinancial companies.

- *Pacific Global Bank has no affiliates.*

Nonaffiliates: Companies not related by common ownership or control. They can be financial and nonfinancial companies.

- *Pacific Global Bank does not share your information with nonaffiliates so they can market to you.*

Joint marketing: A formal agreement between nonaffiliated financial companies that together market financial products or services to you.

- *Pacific Global Bank does not jointly market.*

Other Important Information

Illinois law requires that you opt-in to information sharing. Therefore, before we would share your information with a third party, except where permitted by law, we will obtain your permission.
